Summary:

In their session on April 5, 2006 the Management Boards of the Eurex Exchanges approved the following measures, which will be implemented on **May 2, 2006**:

1. Introduction of options and LEPOs on shares of Fresenius (preferred shares), Hochtief, Lanxess, Salzgitter and Solarworld
2. Inclusion of the new stock options into the German Advanced Market Maker package
3. Extension of maximum expiry dates for all stock options in the German package that are currently reduced to the maximum of twelve months to 24 months
4. Increase of quote obligations for Permanent Market-Making / Advanced Market-Making for all stocks of the benchmark index DAX® to a minimum of 24 months.

Stock Options: Measures in the German Segment

I. Introduction of Stock Options and LEPOs on Shares of Fresenius (Preferred Shares), Hochtief, Lanxess, Salzgitter and Solarworld

1. Introduction Date

In their session on April 5, 2006 the Management Boards of the Eurex Exchanges decided to introduce options, including LEPOs, on the shares of Fresenius (Preferred Shares), Hochtief, Lanxess, Salzgitter and Solarworld. Start of trading will be May 2, 2006. All product parameters can be found in the Contract Specifications for Futures Contracts and Options Contracts at Eurex Deutschland and Eurex Zürich (attachment 1). The new options will form part of the German package for Advanced Market-Making as of May 2, 2006.

The number of exceptions for fulfilling AMM-requirements remains unchanged.

4. Market-Making

Market-Making will be based on Regular Market-Making, Permanent Market-Making and Advanced Market-Making within the German package of stock options and LEPOs. Stock options on Hochtief, Lanxess and Salzgitter will be assigned to Quote Spread Class 7, Fresenius (Vz.) to Quote Spread Class 8 und Solarworld to Quote Spread Class 9.

5. Data Vendor Codes

Data vendor codes will be published on the Eurex website www.eurexchange.com under **Market Access > Member & Vendor Search > Vendor Product Codes**.

6. Transaction Limits, OTC Minimum Block Trade Size, Minimum Size for Cross- and Pre-arranged Trades, Trading Calendar and Transaction Fees

The same values which currently relate to the existing German stock options will apply.

7. Preparations for Start of Trading

- On April 25, 2006 (Tuesday) the options specified above, as well as their associated Margin Classes, will be set up in the Eurex[®] system. Corresponding back office transactions will be transmitted electronically.
- From April 26, 2006 (Wednesday) to April 28, 2006 (Friday) after close of trading, settlement prices for all tradable contract months of the options will be transmitted. In addition, transactions for the PMI file will be generated. The theoretical prices for the options, transmitted within the scope of the end of day processing after 21:00 CET, should be ignored.
- Trading in the new options on shares will start on Tuesday, May 2, 2006. Orders and quotes may be entered in the Eurex[®] system from 07:30 CET onwards.

II. Extension of Maximum Expiry Dates for all German Stock Options and Change of Quote Obligations for Permanent Market-Making in Stocks of the Benchmark Index DAX[®]

As of May 2, 2006, all expiry dates of German stock options that are currently reduced to the maximum of twelve months, will be extended to the maximum of 24 months. At the same time, quote obligations for Permanent Market-Making and Advanced Market-Making in all stocks of the benchmark index DAX[®] will be increased to 24 months. Registration of Market Maker Licenses

Preface

Eurex offers Market-Making for fixed income, equity and equity index options. A Market Maker license is granted upon application according to section 3.3 of the Exchange Rules for Eurex Deutschland and Eurex Zürich. Licensed Market Makers may register with the attached form for different Market-Making packages: Regular Market Making (RMM), Permanent Market Making (PMM) or Advanced Market Making (AMM).

RMM is available for selected equity options where Market Makers are obliged to quote on request.

PMM is available for all fixed income, equity and equity index options. For equity index options Market Makers may choose between three different PMM schemes: PMM, PMM Short (PMS) and PMM Long (PML); the latter is only available for options on Dow Jones EURO STOXX[®] Index, DAX[®] and SMI[®].

AMM is available for pre-defined packages of equity, equity index and fixed income options.

Resignation from the responsibilities is subject to the general rules for Eurex Market-Making. Members are requested to indicate the options in which they wish to make a permanent market in accordance with this agreement and to sign and return the document to Eurex, Sales, 60485 Frankfurt, Fax +49-69-211-1 39 41.

- Revert the member from PMM to Regular Market-Making (RMM) status in products for which RMM is permitted
- Discontinue Promotion as a PMM

Should an AMM not fulfil the minimum requirements for AMMs, Eurex will take the following measures:

- Revert the member from AMM to PMM status for products in which PMM is permitted. Should minimum requirements for PMMs not be fulfilled, the member will also revert to Regular Market-Making (RMM) status for products in which RMM is permitted
- Discontinue promotion as an AMM

The reimbursement of exchange fees as described in section 5 will not be granted unless the relevant market maker obligations have been fulfilled.
