Summary:

On May 28, 2009, the company Enel SpA published the following details for the planned capital increase with subscription rights for the shareholders of Enel SpA at a subscription ratio of 25:13. Subscription price of the new shares will be Euro 2.48. The subscription period will start on June 1, 2009.

As a consequence of the capital increase, an adjustment of the Eurex options and the Eurex stock futures contract on Enel SpA (ENL5/ENLF) will become necessary.

Ex date will be **June 1, 2009**.

This circular describes the adjustment procedure.

The new shares will not be entitled to the final dividend of 2008 at the amount of EUR 0.29. Consequently, a dividend disadvantage of EUR 0.29 will have to be considered for the calculation of the R-factor.

The ISIN of the Enel SpA share (IT0003128367) will remain unchanged.

Procedure

Determination of Adjustment Factor (R-Factor)

The official closing auction price of the Enel SpA share at Borsa Italiana on May 29, 2009 will be the basis for determination of the R-factor.

The R-factor will be determined with eight decimal places. It is calculated in the following way:

$$R = ((\text{number of existing shares} / \text{number of new shares}) * (1 - ((\text{issue price of new shares} + \text{dividend disadvantage}) / \text{closing auction price}))) + ((\text{issue price of new shares} + \text{dividend disadvantage}) / \text{closing auction price})$$

$$R = ((25 / 38) * (1 - ((2.48 + 0.29) / \text{closing auction price}))) + ((2.48 + 0.29) / \text{closing auction price})$$

Options

1. Adjustment of Strike Prices and Contract Sizes

All existing strike prices will be multiplied by the R-factor.

The contract size will be divided by the R-factor.

The version number of the existing series will be increased by 1.

The adjusted strike prices and contract sizes will be published via the **Market Supervision Messages** window immediately after close of trading on the last cum trading day.

New series with standard contract size 500 and version number 0 will be introduced effective ex date.

All existing orders and quotes will be deleted after close of trading on the last cum trading day.

Adjustment will also be made for existing positions in OTC Flexible Options.

2. Exercises

Upon exercise of an adjusted series cash settlement will be made for the fractional part of the new contract size. In adjusted series as of version 2 there might appear discrepancies in the delivery process. Report RPTTA111 (All Active / Inactive Series) represents those parts of the contract size, for which cash payment will be made upon exercise of an adjusted series.

Futures

1. Adjustment of Contract Size and Variation Margin

Adjustment will be made with the same R-factor as for the options.

To adjust the calculation of the Variation Margin of the following exchange trading day, settlement prices of the last cum trading day will be multiplied by the R-factor.

The new contract size will be calculated as follows:

$$\text{Contract size new} = \text{contract size old} / \text{R-factor}$$

All outstanding orders and quotes will be deleted after close of trading on the last cum trading day.

Adjustment will also be made for existing positions in OTC Flexible Futures.

2. Introduction of a new Contract

A new contract will be introduced on Enel SpA with a standard contract size of 500 and the new product code ENLG.

The exact date of introduction will be published via the **Market Supervision Messages** window.

As soon as the new contract is available for trading and there are no series with open interest in the original contract on Enel SpA (ENLF), trading in this contract will be set on "HALT" and finally discontinued.
