REMINDER: Eurex Clearing circulars and Readiness Newsflashes: New subscription procedure and new subscription categories

With this circular we would like to remind you about an important required action:

On 21 March 2019, Eurex Clearing announced a fully revised and improved subscription procedure for Eurex Clearing circulars and Readiness Newsflashes (see attached Eurex Clearing circular 030/19).

Due to requests from our clients for more time to prepare for the transition, the introduction date of the new procedure and new subscriptions will be postponed to **Monday**, **20 May 2019**.

Important: All current Eurex Clearing circular subscriptions will be deleted after **Friday**, **17 May 2019** (exception: subscriptions of Eurex Clearing Central Coordinators).

In order to continue receiving Eurex Clearing circulars and Readiness Newsflashes, it is therefore important that you enter your new subscriptions **before Monday, 20 May 2019** on our dedicated <u>subscription page</u> (if not already done).

The subscription is only complete once you have clicked on the link in the following confirmation e-mail you will receive automatically.



Eurex Clearing circulars and Readiness Newsflashes: New subscription procedure and new subscription categories

Summary

On **15 April 2019**, Eurex Clearing will launch a new concept for Eurex Clearing's circulars and Readiness Newsflashes with the following features:

- New subscription procedure allowing immediate sign-up
- New, more granular subscription categories
- A single subscription process for Eurex Clearing circulars and Readiness Newsflashes

This will significantly simplify the sign-up process for Clearing Members and improve usability.

Action required:

The new process will impact all current recipients of Eurex Clearing circulars and Readiness Newsflashes. A renewed subscription will be required, since all current subscriptions <u>will be deleted</u> after 12 April 2019 (due to personal data protection reasons).

Eurex Clearing's circulars and Readiness Newsflashes: New subscription procedure and new subscription categories

In order to harmonise communication and reduce complexity for Clearing Members, a new integrated subscription service will replace the separate subscriptions to Eurex Clearing circulars and Readiness Newsflashes via the Members Section. As of today, Clearing Members are able to subscribe to Eurex Clearing circulars and Readiness Newsflashes directly on the Eurex Clearing website under the following link:

The re-designed information resources, together with the newly introduced circular and Readiness Newsflash categories, will allow Clearing Members and registered designated persons to make their individual choice of the content they require for their activities with Eurex Clearing. We strongly recommend to subscribe as soon as possible.

1. New subscription categories

We have revised the structure of the subscription categories you can select.

The general topic "Eurex Clearing" is split into subtopics that are more refined where you can select the subscriptions you require and therefore only receive the content relevant for you. The new categories for Eurex Clearing are:

- Regulatory/Compliance/Rules & Regulations
- Products, Functionalities & Services
- Releases & Technology
- Pricing
- Risk, Margin, Collateral
- Other subjects

Officially registered Central Coordinators of a Clearing Member will continue to receive all Circulars and Readiness Newsflashes.

2. Required actions for customers in order to remain updated

Please be aware that all current subscriptions for circulars and Readiness Newsflashes will be deleted after 12 April 2019. This measure is required due to the deeper granularity of the new categories and data protection regulations.

Action required:

As you are currently subscribed to Eurex Clearing circulars and Readiness Newsflashes, you have to select your subscriptions on the new, dedicated <u>subscription page</u> and enter your e-mail address.

Otherwise, you will no longer receive Eurex Clearing circulars and Readiness Newsflashes from 15 April 2019.





Please follow the steps below:

1. Go to our new subscription page:

https://www.eurexclearing.com/clearing-en/resources/circular-newsletter-subscription and subscribe to the topics for which you would like to receive updates. Once you have selected your categories and submitted your subscription, you will receive a confirmation e-mail which needs to be finally confirmed.

2. If you want to unsubscribe, please simply use the respective link in the footer of each circular or Readiness Newsflash.

Starting 15 April 2019, Eurex Clearing will also harmonise its several e-mail addresses used. From this date onwards, Eurex Clearing circulars and Readiness Newsflashes will use one single sender address: client.info@eurexclearing.com.

If you are using automated routines to handle your inbound e-mails, it might be necessary to adjust them or add the new sender address of Eurex Clearing.
