With this circular Eurex Clearing announces the introduction of CCP Release 12.0 on 6 February 2017 which focuses on the introduction of T2S wave 4.

CCP Release 12.0 is mandatory for all Clearing Members of Eurex Clearing.

A Member simulation is planned for CCP Release 12.0/T2S wave 4 from 8 August 2016 onwards.

Information on the CCP Release 11.0 in the fourth quarter of 2016 will be provided at a later point in time.

In the fourth migration wave of T2S on 6 February 2017, Clearstream Banking Frankfurt AG (CBF) will migrate its securities settlement business to T2S, the new European securities settlement system in central bank money.

The implementation of T2S wave 4 will affect the services provided by Eurex Clearing which will be adjusted to conform to T2S requirements. Eurex Clearing will adjust its processes and products settled to ensure continuity of its services for all affected clients in the new T2S environment. In addition, Eurex Clearing will adjust its systems and processes to include changes prioritised by customers based on new functionalities offered by T2S.

The following changes will be introduced with CCP Release 12.0:

- New T2S business day: adjustment of the Eurex Clearing business day to T2S timelines.
- Delivery management: introduction of new cut off-times for the different instruments and introduction of intraday aggregation runs; changes in late delivery handling and overall usage of T2S features.
- **Cash:** adjustment of cash runs and their effect on delivery management and changes in timing restrictions of external systems and entities.
- Gross Delivery Management (GDM): adjustment of GDM according to the new T2S business day.
- **Corporate Actions:** adjustments according to the amendments planned by the Central Securities Depositories (CSDs) in order to support harmonisation efforts in the field of corporate actions.
- **Reporting:** batch reporting will be converted to continuous reporting, amendments in the reporting schedule and to the reports.
