2.2 Basis fee for the utilization of the Exchange EDP

For Multi-Member System Provider, an additional basis fee in the amount of EUR <u>34</u>,000 per month will be charged for the technical connection to the individual interfaces and the utilization of the Exchange-EDP, as well as for the other services pursuant to § 5 paragraph 2 of the General Terms and Conditions to the Provider Connection Agreement of EFAG. The basis fee shall not apply to the Multi-Member-System Providers who are either Trading Participants on the Eurex Exchange or who are connecting only affiliated companies to the Exchange-EDP.

2.3 [Deleted] Dissemination of un-netted market data to Trading Participants via Multi-Member-System Provider installations

For the dissemination of un-netted market data (Eurex EMDI, Eurex EOBI Futures, Eurex EOBI Options) to a Trading Participant via a Multi-Member-System Provider installation a monthly fee of EUR 500 per Trading Participant is charged to the Service Provider.
